WRITING REQUIREMENTS:

General requirements: The paper (only one paper) will be written fully in Romanian (only for Romanian authors) and in one of the international-circulation languages: English, French, . Spacing is one line, using the option Justify. Maximum number of pages: 20, A4 format and setting of pages: left 30 mm; right 25 mm, up 25 mm, down 25 mm.

Title of paper: Times New Roman, Bold, size 12, spacing 1 pt., capital letters, centered;

Author name: Times New Roman, Bold, size 12, centered, spacing 1 pt., two lines from the title of the paper followed by the scientific title;

Name of the institution: Times New Roman, size 12, normal, centered, spacing 1 pt., one line from the name of the author;

Abstract: Times New Roman, Bold, size 10, two lines from the name of the institution. The text of the abstract will normal, justify, spacing of one line, size 10, written in a language of international circulation and containing a maximum of 200 words.

Content of the paper: Two spaces from the abstract written with size 12, spacing 1 pt., justify, normal;

Chapters (Times New Roman, Bold, size 12, alignment left); **Subchapters** (Times New Roman, Bold, size 12, alignment left);

Bibliographic notes will be numbered in text between right parentheses according to the order of papers in the bibliography (Author- surname, name, Title of the paper -italic, Publisher, Place of Publication, year, page).
