In this regard, we note that in the next period (approximately 1-3 years), 4 teachers holding the academic rank of professor or academic rank of associate professor will be eligible for retirement, which will generate an imbalance of the above mentioned criterion.</p> <p>Advertisements for a vacancy contest for the post of associate professor is justified by the need of developing a sustainable policy to develop human resources directed towards teaching disciplines by teachers trained in special disciplines, and also towards strengthening research as an essential element for the evaluation of the university studies programme and higher education institution.</p>

The application for entry in the contest, signed by the candidate accompanied by a statement on his own responsibility regarding the veracity of the information submitted in the dossier;</p> <p>A2. A proposal for the development of the candidate's university career, both from the point of view of teaching activity as well as from the point of view of the activities of scientific research; the proposal shall be drawn up by the applicant, shall include up to 10 pages and is one of the main criteria for differentiating the candidates;</p> <p>A3. Curriculum vitae of the applicant, signed by candidate on each page which should include information on: studies carried out, and the diplomas obtained; professional experience and relevant workplaces; projects of research and development on which he has run as a director of project or în care in which he was a member, by specifying for each source of funding; awards or other items for the recognition of the applicant's scientific contributions;</p> <p>A4. A7. Summary of the doctoral thesis in an international language, and Romanian of maximum one page;

Copies of other diplomas attesting candidate studies (high school graduation degree, bachelor's degree, master's degree, certificate for psychological and pedagogical training or, if the original diplomas are not recognized in Romania, certificates of recognition or equivalence; copies after other diplomas of the candidate. A10. Copy of the identity card;

A11. Copies of documents evidencing change of name, if appropriate (certificate of marriage or proof name change);

A12. Personal statement of the applicant that he/she is not in any circumstances of incompatibility laid down in the Law 1/2011 with subsequent modifications and supplements, the Law of National Education Methodology and Framework issued at national level;

A13. Medical certificate attesting that he / she is able to carry out educational activity;

A14. List of referents with their contact dates, at least three personalities in that domain in the country or abroad, outside CBU who have accepted to write letters of recommendation regarding the candidate's professional qualities.

A15. The payment of the fee for entry in the contest.

A16. Statement of assuming full responsibility, in the original, (holograph) signed by the candidate to assume correctness of the data included in the file and the fact they refer to his /her own activities and achievements, otherwise the candidate facing the consequences of false statements, according to the law.

A17. Portfolio including maximum 10 of the candidate's papers considered to be the most representative, scanned on a CD. Besides the electronic support will also include the list of candidate's papers according to A4 in word.

If there are works that are not available in electronic format or cannot be scanned (music or theatrical performances, paintings, etc.) shall be deposited records or photos.
