Description of the competition procedure

The procedure will be in compliance with the Education Law no. 199/2023, with the subsequent modifications and completions, with the Framework Methodology of competition for filling teaching and research vacant positions in higher education approved by H.G. no. 1339/2023, and with the Methodology of competition for filling teaching positions and research positions available in University "Constantin Brâncuşi" from Târgu-Jiu", approved in the meetings of the Senate of the University "Constantin Brâncuşi" from Târgu-Jiu of 13.03.2024.

- 1. The competition file constituted by the candidate, together with the electronic support, which contains the scanned file, is submitted with registration number to the address of the higher education institution specified on the competition website, directly or through postal services or courier to confirm receipt.
- 2. The file registered at the level of the higher education institution is transmitted and managed at the level of the Legal Compartment. The candidate has the right to inform and verify, within the Legal Compartment of the University if the personal file is fully constituted in order to obtain the legality notice. The university does not have the obligation to contact the candidates to communicate the possible problems existing in the application file.
- 3. The scientific commission appointed by the decision of the rector of the "Constantin Brâncuşi" University of Târgu-Jiu at the proposal of the Board of Directors, for verifying the information from the File of fulfilling the standards submitted by the candidate is meeting at the request of the Legal Department and issues a resolution regarding the fulfillment/failure of the minimum standards. specific to the position, within 3 working days from the end of the

registrations. Only the publications arising will be taken into account, that is, those that specified volume, number, pages.

- 4. The Legal department advises on legality on the basis of the resolution from paragraph 3 and other documents necessary for registration in the competition. The notice is communicated to the candidate within a maximum of 48 hours from its issuance, but at least 5 working days before the first test of the competition.
- 5. The evaluation and verification of the candidate's skills and professional performance in the field of the position put up for competition, contained in the standards fulfillment sheet for registration in the competition, is the competence of the competition committee.
- 6. The Rector approves applications for registration in the competition for candidates who have received the legality notice.
- 7. After the approval of the applications by the Rector, they are communicated to the candidates no later than 48 hours after approval, but not less than 5 working days before the first test of the competition.

In the case of a negative notice, the candidate can appeal the notice within 24 hours to the UCB Board of Directors. The answer is communicated to the candidate within 24 hours of its issuance.

If the candidate is not satisfied with the answer received, he can address the University Senate within 24 hours of receiving the answer from the Board of Directors. The University Senate will analyse and communicate the answer within 48 hours of its issuance.

List of documents

In order to register for the competition of a university professor position, the candidate prepares a file containing the following documents:

- **Al.** The application for registration, signed by the candidate, which includes a statement on his own responsibility regarding the veracity of the information presented in the file;
- **A2.** Proposal for the development of the candidate's career, which will take into account the didactic and the scientific research activities. The proposal is drafted by the candidate, comprises a maximum of 10 pages and it is one of the main criteria for deciding the tie-breaking of candidates.
- **A3. Curriculum vitae** of the candidate-Europass model (in original signed on each page). Curriculum vitae of the candidate in electronic format, in PDF format, without signature, which under the heading "Personal data" should contain only the name, first name of the candidate and, optionally, the e-mail address. The candidate assumes the condition that the written and the electronic format contain the same information, minus the personal data (address, phone, e-mail, etc.) and the signature, omitted in the document in electronic format. The CV must include:
- a) information about the studies carried out and the diplomas obtained;

- b) information about relevant professional experience and jobs;
- c) information about the research-development projects and grants that he/she led as project director or in which he/she was active as a member, indicating for each funding source, the amount of funding and the main publications or patents resulting;
- d) information about awards or other elements recognizing the candidate's scientific contributions;
- e) other relevant information.
- **A4. Candidate's list of works** in printed format (in original, signed on each page) and in electronic format, PDF type, without signature. The candidate assumes the condition that the written and electronic formats contain the same information, minus the signature, omitted in the electronic document. The list of works will be structured as follows:
- a) the list of a maximum of 10 works considered by the candidate to be the most relevant for their own professional achievements, which are also included in electronic format in the file and which can also be found in the other categories of works provided for in this article;
- b) doctoral thesis or theses;
- c) books and chapters in books;
- d) articles/studies, published in journals from the main international scientific stream;
- e) publications in extenso, appearing in papers of the main international specialized conferences;
- f) projects of research-development-innovation on a contract/grant basis that he/she led as project director or in which he/she was active as a member, indicating for each the funding source;
- g) invention patents and other industrial property titles;
- h) other works and scientific contributions or, as the case may be, in the field of sports performance.

It is recommended to mention all the information useful for identifying the respective publication, such as: title of the journal (including ISSN), rated (Impact Factor for the last year), volume, page, name and place of the publisher, WoS indexed journal hyperlink, WoS indexed work hyperlink (including the WOS code), BDI indexed journal hyperlink, BDI indexed work hyperlink indicating the respective Databases, etc.

This information is absolutely necessary for the works selected by the candidate in point (a) for teaching positions and those that support the candidate's fulfillment of the minimum standards, UCB and national, specific to the professor position.

A5. The verification sheet of fulfillment for the specific standards of the position, completed and signed by the candidate, in printed format (in the original, signed on each page). The verification sheet for the position of university professor is drawn up by the candidate according to the minimum standards provided by the Order of the Minister in force, according to Art. 156, (1) lit. a) and paragraph (2) of

Law no. 199/2023 – Higher Education Law, with subsequent amendments.

- **A6.** Documents regarding the holding of a doctor's degree: the copy according with the original doctor's degree or, if the original doctor's degree is not recognized in Romania, the copy according with original of the attestation of its recognition or equivalence.
- **A7. Summary of the doctoral thesis** in Romanian language and in a language of international circulation (maximum one page for each language).
- A8. Other diplomas attesting the candidate's studies: copies of other diplomas attesting the candidate's studies: (baccalaureate diploma, bachelor's degree, master's/advanced studies) or, if the original diplomas are not recognized in Romania, their recognition or equivalence certificates; xerox copies of other diplomas certifying the candidate's studies. The xerox copies are signed by the candidate for certification "according to the original".
- A9. Transcripts, diploma supplements or school statements issued for each cycle of study.
- **A10.** Copy of identity card, candidate's certificate "according to the original" or, as the case may be, of the passport or another identity document drawn up for an equivalent purpose to the identity card or passport.
- **A11.** Copies of documents certifying by the candidate "according to the original" of the documents which attests to the name change, if applicable (marriage certificate or proof of name change).
- **A12. Declaration on the candidate's own responsibility** that he is not in any situation of incompatibility provided for in Law no. 199/2023 Higher Education Law, with subsequent amendments and additions and the Framework Methodology issued at national level.
- A13. Certificate of criminal record.
- A14. Certificate of behavioral integrity.
- **A15. Medical certificate** from which it follows that he is fit to carry out teaching activity, issued on a specific form adopted by joint order of the Minister of Education and the Minister of Health.
- **A16.** The medical certificate for practicing the teaching profession, issued according to the provisions of the joint order of the Minister of Education and the Minister of Health.
- **A17.** Letters of recommendation in accordance with art. 13 of HG 1339/2023. At least 3 letters of recommendation from personalities in the respective field from abroad, who agreed to prepare letters of recommendation regarding the candidate's professional qualities.
- **A18.** Copy by order of the Minister regarding the granting of the doctoral supervisor qualification or, as the case may be, the copy of the habilitation certificate.
- A19. Statement of responsibility, in original (handwritten) signed by the candidate. The statement must state the correctness of the data in the file and the fact that it relates to his own activities and achievements, otherwise the

	candidate will bear the consequences of making false statements, in accordance with the legislation in force. A20. The folder containing a maximum of ten of the candidate's most significant works, in scanned form, on electronic support (CD/DVD/stick/), and books and book chapters will be submitted in physical format. In addition, the electronic support will also include the candidate's list of works in Word format. A21. Document for paying the registration fee for the competition. A22. Other documents: The file will include the cover page and the description.
