The description of the academic position	Associate Professor position, position 9, Department of Legal and Administrative Sciences. The disciplines in the structure of the position can be found in the curriculum of the undergraduate Law study program, as well as of the master's degree programs Judicial Career and Legal Protection of the Person and His Patrimony. The position is open for competition for an indefinite period. The opportunity to open this position is given by the need to comply with the ARACIS standards in the field of evaluating master's degree programs regarding the requirement to cover most of the disciplines existing in the curricula of master's degree programs with teaching staff holding the teaching rank of associate professor and university professor. At the same time, the competition for this position takes into account the need to develop a sustainable human resources policy, oriented towards ensuring the teaching and seminarizing of specialized disciplines by teachers trained in the specialty of the disciplines, and, at the same time, towards consolidating research activities, an essential element for the evaluation of university study programs and the higher education institution, these being intended to contribute to the achievement of the objectives of the development plan of the faculty and the department.

Description of the competition procedure	The competition is carried out in accordance with H.G. no. 1339/2023 on the approval of the Competition Framework Methodology for filling vacant teaching and research positions in higher education, Law no. 199/2023 - Higher Education Law, as subsequently amended and supplemented, Law no. 53/2003 on the Labor Code, republished, as subsequently amended and supplemented; Competition Methodology for filling vacant teaching and research positions in the "Constantin Brâncuși" University of Târgu Jiu", approved in the meeting of the Senate of the "Constantin Brâncuși" University of Târgu-Jiu on March 13, 2024.
List of documents	In order to register for the competition for a teaching position, the candidate prepares a file containing the following documents: A1. Application for registration for the competition, signed by the candidate, which includes a declaration on his/her own responsibility regarding the veracity of the information presented in the file. A2. Proposal for the candidate's career development. Candidates for teaching positions will consider both the teaching side and that of scientific research activities. The proposal is written by the candidate and includes a maximum of 10 pages. A3. Curriculum vitae of the candidate - Europass model (in original signed on each page). Curriculum vitae of the candidate in electronic format, PDF type, without signature, which in the "Personal data" section should include only the candidate's last name, first name and, optionally, e-mail address. The candidate assumes the condition that the paper and electronic formats contain the same information, except for personal data (address, telephone, e-mail, etc.) and signature, omitted in the electronic document. The CV must include: a) information about the studies completed and the diplomas obtained; b) information about the professional experience and relevant jobs previously held; c) information about the research and development projects and grants that he/she led as a project director or in which he/she worked as a member, indicating for each the source of funding, the volume of funding and the main publications or patents resulting; d) information about awards or other elements of recognition of the candidate's scientific contributions; e) other relevant information. A4. List of the candidate's works in printed format (in original, signed on each page) and in electronic format, PDF type, without signature. The candidate assumes the condition that the printed and electronic formats contain the same information, except for the signature, omitted in the electronic document. The list of works will be structured as follows: a) list of a maximum of 10 works considered by the candidate to be the most

relevant for his/her professional achievements, which are also included in electronic format in the file and which can also be found in the other categories of works provided for in this article;

b) doctoral thesis or theses;

c) books and chapters in books;

d) articles / studies, published in journals from the main international scientific flow;

e) full-text publications, appearing in proceedings of the main international specialized conferences;

f) research-development-innovation projects based on contract / grant that he/she led as project director or in which he/she worked as a member, indicating the source of financing for each;

g) patents and other industrial property titles; h) other scientific works and contributions or, as the case may be, in the field of artistic creation / sports performance.

A5. Verification sheet of the fulfillment of the standards specific to the position, completed and signed by the candidate, in printed format (in original, signed on each page). The verification sheet is drawn up by each candidate according to the minimum standards provided by the Order of the Minister in force, according to art. 156 paragraph. (1) letter. a) and paragraph (2) of Law no. 199/2023 - Law on Higher Education, with subsequent amendments and completions for each field, to which are added, as the case may be, the additional standards established by the faculty council.

A6. Documents relating to the possession of a doctoral degree. For the position of associate professor, proof of possession of a doctoral degree is required (a true copy of the original of the doctoral degree or, if the original doctoral degree is not recognized in Romania, a true copy of the certificate of its recognition or equivalence).

A7. Summary of the doctoral thesis in Romanian and in an internationally spoken language (maximum one page for each language).

A8. Other diplomas attesting the candidate's studies: copies of other diplomas attesting the candidate's studies (baccalaureate diploma, bachelor's degree, master's degree / advanced studies) or, if the original diplomas are not recognized in Romania, their certificates of recognition or equivalence; copies of other diplomas attesting the candidate's studies. The copies are signed by the candidate for certification "true to the original";

A9. Transcripts, diploma supplements or school reports issued for each cycle of studies;

A10. Copy of the identity card certified by the candidate "according to the original" or, as the case may be, of the passport or another identity document drawn up for a purpose equivalent to the identity card or passport;

A11. Copies certified by the candidates "according to the original" of the documents attesting to the change of name, if applicable (marriage certificate or proof of name change);

A12. Declaration on the candidate's own responsibility that he/she is not in any situation of incompatibility provided for in Law no. 199/2023 – Higher Education Law, with subsequent amendments and completions and the Framework Methodology issued at national level;

A13. Criminal record certificate;

A14. Certificate of behavioral integrity;

A15. Medical certificate proving that he is fit to carry out teaching

	activity, issued on a specific form adopted by joint order of the Minister of Education and the Minister of Health; A16. Medical certificate for the exercise of the teaching profession, issued in accordance with the provisions of the joint order of the Minister of Education and the Minister of Health; A17. Letters of recommendation, as follows, in accordance with art. 13 of GD 1339/2023: a) for the positions of associate professor or scientific researcher level II, three letters of recommendation from personalities in the respective field, from the country or abroad, external to the higher education institution whose position is being advertised, who have agreed to draft letters of recommendation regarding the candidate's professional qualities. A18. Declaration of responsibility, in original (holographic) signed by the candidate. The declaration must affirm the correctness of the data in the file and the fact that they refer to their own activities and achievements, otherwise the candidate will bear the consequences of false declarations, in accordance with the legislation in force. A19. The folder containing a maximum of ten of the candidate's most significant works, in scanned form, on electronic media (CD/DVD/stick/), and the books and chapters from the books will be submitted in physical format. In addition, the electronic media will also include the candidate's list of works in Word format. A20. Document for payment of the competition registration fee; A21. Other documents: (1) If there are works that are not available in electronic format or cannot be scanned (theatrical or musical performances, paintings, etc.), recordings or photographs will be submitted. (2) The folder will include a cover page and a list of contents. (3) A CD/DVD/stick, with its entire contents scanned, including the folder with the 10 significant works, is also attached to the competition folder, in order to be transmitted to the competition committee. (4) The Certificate attesting to the psycho-pedagogical training is also submitted with the registration folder. (5) If proof of completion of the psycho-pedagogical module is not provided, the admitted candidate will complete, within 2 years of taking up the position, a psycho-pedagogical training program for higher education, of 30 ECTS/SECT transferable study credits. This obligation will constitute a clause of the CIM, the contractual relations ceasing by law on the date of completion of the 2 years. (6) By way of exception to the provisions of paragraph (6), in order to occupy a teaching position in higher education institutions, graduates of a psycho-pedagogical training program corresponding to a number of 60 ECTS/SECT transferable study credits may also register for the competition.
